Common Grant Types for Nonprofits - Quick Reference Guide

Operating/General Support Grants

What: Unrestricted funding for day-to-day operations, overhead costs, salaries, rent, and core activities **Where to find:** Candid Foundation Directory, local community foundations, corporate foundations **Note:** Highly sought after but competitive; provides crucial organizational flexibility.

Program/Project Grants

What: Support specific initiatives, projects, or programs with defined goals and timelines **Where to find:** Candid Foundation Directory, Grants.gov, private foundations, corporate giving programs **Note:** Most common type for nonprofits; easier to obtain than general operating support.

Capacity Building Grants

What: Fund organizational infrastructure, staff training, technology upgrades, systems, or equipment to strengthen operations **Where to find:** Capacity-focused foundations, United Way, corporate foundations, management support organizations **Note:** Popular for organizational development and strengthening internal capabilities.

Capital Grants

What: Fund major purchases like buildings, renovations, equipment, or other fixed assets **Where to find:** Capital campaign consultants, major donor prospects, family foundations, corporate foundations **Note:** Often part of comprehensive fundraising campaigns; require detailed project plans.

Planning Grants

What: Fund feasibility studies, strategic planning processes, or preliminary research before launching major initiatives **Where to find:** Community foundations, planning-focused funders, management support organizations **Note:** Smaller amounts that can lead to larger implementation grants.

Multi-Year Grants

What: Provide funding over several years rather than single-year awards **Where to find:** Major private foundations, family foundations, some government programs **Note:** Preferred by nonprofits for program stability and long-term planning.

Emergency/Crisis Relief Grants

What: Immediate funding for disaster response, organizational crises, or urgent community needs **Where to find:** Emergency response foundations, community foundations, corporate emergency funds **Note:** Time-sensitive; often have rapid application and decision processes.
