OGDEN UNITED PARTNERSHIP - THE GOAL OF THE OGDEN UNITED PARTNERSHIP IS TO ENSURE ALL CHILDREN AND YOUTH HAVE ACCESS TO GREAT SCHOOLS AND STRONG SYSTEMS OF FAMILY AND COMMUNITY SUPPORT THAT WILL PREPARE THEM TO ATTAIN AN EXCELLENT EDUCATION AND SUCCESSFULLY TRANSITION TO COLLEGE AND CAREER. IN 2016, UWNU RECEIVED A FIVE-YEAR PARTNERSHIP FOR STUDENT SUCCESS GRANT FROM THE UTAH STATE BOARD OF EDUCATION. DONORS OFTEN DESIGNATE TO SPECIFIC AGENCIES WHEN THEY CONTRIBUTE TO UNITED WAY FUNDRAISING CAMPAIGNS.
